**COMMUNITY WORKFORCE DEVELOPMENT AGREEMENT (CWDA):** In addition to all prevailing wage requirements, skilled and trained workforce requirements, and Labor Code obligations, the District has implemented a Community Workforce Development Agreement (CWDA) for this project.
