**RFI DEADLINE: ALL REQUESTS FOR CLARIFICATION must be submitted no later than 4:00 PM Wednesday, August 16<sup>th</sup>, 2023.** Requests received after the deadline may not receive a response. Failure of a bidder to request clarification of apparent errors or ambiguities waives the bidder's right to object to a clarification issued later by the Architect or BBC. Refer to the Request for Information document in the project's Front End Documents folder of BuildingConnected for specific instructions for the **electronic submission of all RFI requests**. RFI responses will be issued in an addendum.

**DISTRICT PREQUALIFICATION:** M/E/P Subcontractors must be prequalified if the contract utilizes a Lease-Leaseback delivery method. This applies to Mechanical, Electrical, and Plumbing Subcontractors (C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43, and C-46). The District must receive applications at least ten (10) business days prior to the scheduled bid opening on any advertised project in order for the candidate to qualify for that project. Please visit [www.qualitybidders.com](http://www.qualitybidders.com) and follow the Contractor Instructions for creating an account and submitting your prequalification application.

**PROJECT LABOR AGREEMENT:** All Subcontractors must comply with the Project Labor Agreement (PLA) implemented on this project by the District.

**SKILLED AND TRAINED WORKFORCE:** Subcontractors at every tier are required to use a “skilled and trained workforce” at the minimum percentages and as defined in Public Contract Code section 2600, et seq. and Education Code section 17407.5 to perform all work that falls within an appropriate occupation in the building and construction trades.

**Disabled Veteran Business Enterprise (DVBE):** DVBE participation is encouraged.
